All other governance remains as is. Each member library has their own contract with Overdrive and collection development falls to the adopted policies of the purchasing library.

Cataloging Standards update. Shantry Miller provided a summary of the recommended updates. Susan Centrella led the committee as they went through the document. Judy Boyce moved and Sam Keeney seconded that the Cataloging Standards be approved as presented. Motion carried.

Linda released the ad hoc Nominating Committee of Rachel Crocker and Kate Mutch.

Linda called for nominations from the floor three times for each position. There were none. Rachel Crocker moved to accept the ballot as presented, Sam Kenney seconded and the motion passed.

Linda then handed the gavel over to Rachel Crocker, incoming President.

Rachel thanked Linda for years of service to the WYLD governing board.

With no further business, Sam Keeney moved and Lisa Scroggins seconded that we adjourn the meeting. The motion passed and the meeting was adjourned at 9:27 a.m.
