The most important task of the WYLD Governing Board was to reevaluate the WYLD fees and cost recovery dues. The Board Chair established an ad hoc committee to review current and historical data and make a recommendation to the WYLD Governing Board.

The following recommendations were approved by the WYLD Governing Board:

- Keep base fees as they are (\$1,500 for Academic, Public, and the State Library; \$1,000 for School Libraries; and \$750 for Special Libraries)
- Keep the \$400 annual Network Fee
- Increase the cost recovery dues from a 3.5% annual increase to a 4.5% annual increase

Additionally, the WYLD Governing Board voted to realign the distribution of the \$400 network fee.
