State Librarian Report

Things are going well. Abby was out of the office for much of October. 2025 is 35 years for Wyoming Goes WYLD; it has been 20 years since WYLD launched. Working on ways to preserve the history of our system.

WYLD Program Manager Report

Today is the mailing list switchover to the new service. It's taking a bit of time because we had to move the domain name, but emails are coming through and working. It will still take a bit of tweaking. All names stayed the same except two, which have been communicated. Archives have all been downloaded, but right now it takes an extra app to actually view them. Hoping the new service will be more reliable, and provide more tools. An added benefit is being less expensive.

Still working on the ILL migration testing. Developers have moved the ASPEN piece onto the test server. So far so good. Next step will be testing with a few libraries. At the same time Bywater is working with OCLC (at OCLC's bequest) to integrate ASPEN with OCLC program. It's a nice backup option. It's possible that we may need a resolution from the governing board. It's possible there will be some pushback. It will save close to \$60,000.
